Emissions reduction targets and further initiatives

Progress to date

DotEcon achieved a reduction of 64%, from 40.60 tCO_{2e} in the previous financial year (baseline) to 14.50 tCO_{2e} in the last financial year. This huge reduction has been the result of there not having been any business air travel in this financial year.

There has been a slight increase (0.8 tCO_{2e}) in employee commuting and working from home emissions, which is the result of a 10% increase in the number of employees relative to the previous financial year.

Further targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

- A move to 100% renewable energy in the office.
- Flexible working practices to reduce commuting.
- We encourage interaction with clients, especially those outside of the UK, by electronic means wherever feasible to reduce travel needs.
- Promoting environmental awareness, policies and initiatives through our business.

*Projected future
reductions*

We project that carbon emissions will decrease over the next five years to 10 tCO_{2e}. This is a reduction of 31 % relative to the current year and a reduction of 75% relative to the base year.

Declaration and sign off

This carbon reduction plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standards for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard¹ and using the appropriate Government emission conversion factors for greenhouse gas company reporting.²

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard.³
